### **NOTICE OF RACE**

**Organizing Authority: The San Francisco Yacht Club, Belvedere, California**

#### **1. RULES:**

1.1 This regatta will be governed by the 'rules' as defined in the Racing Rules of Sailing (RRS).

1.2 RRS 40 is deleted and replaced with: "All competitors shall wear life jackets or adequate personal buoyancy while racing." Note that Flag Y will not be displayed.

#### **2. ELIGIBILITY AND ENTRY:**

1.1 The regatta is open to all members of the Finn Class

1.2 Eligible boats may be entered by completing the attached Entry Form and returning it to the SFYC Race Office, with the required fee.

1.3 The entry fee is \$65, if received by June 10, 2009, and \$75 if received after that.

4. **SAILING INSTRUCTIONS:** Sailing instructions will be available after June 10, 2009, at The San Francisco Yacht Club and on our website, [www.sfyc.org](http://www.sfyc.org).

5. **RACING AREA AND COURSES:** The racing area will be in the vicinity of Southampton Shoal. The courses will be described in the sailing instructions.

6. **REQUIRED EQUIPMENT:** Each boat shall be equipped with an adequate bowline suitable for towing.
7. **COMMUNICATIONS:** The Race Committee may communicate information about the regatta by loud hailer.
8. **SCORING:** As many races as practicable are scheduled, of which two (2) must be completed to constitute a series. When fewer than six races are completed, a boat's series score will be the total of her race scores. If six or more races are completed, each boat's worst score will be excluded.
9. **DOCKAGE and TRAILERS:** Boats will be launched from the Youth Sailing Dock. Trailer storage will be located in the SFYC parking lot, as directed by the Harbormaster. Please contact the Harbormaster upon arrival, at 415-435-4202, for directions.
10. **PRIZES:** Prizes will be awarded to the top three boats in the regatta. The trophy presentation will be held at the SFYC Youth Sailing area after the racing on Sunday.
11. **SOCIAL:** All racers are invited to take advantage of our Dining Room service or small plate special meals in the Bar. Reservations are requested for Friday or Saturday evening. No host breakfast service in the main dining room begins at 0830 on Saturday and Sunday. Complimentary beer will be provided after racing each day.
