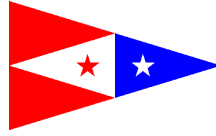

SAILING INSTRUCTIONS

(Notice of Race attached at end)

1 CHANGES TO SAILING INSTRUCTIONS

Any change to the sailing instructions will be posted before 0900 hours on the day it will take effect, except that any change to the schedule of races will be posted by 1800 hours on the day before it will take effect.

2 COMMUNICATIONS WITH COMPETITORS

- 2.1 The NOR, SIs, and amendments thereto will also be posted online at www.sfyc.org
- 2.2 The race committee may use VHF USA channel 65A to communicate information about the races.
- 2.3 The race committee will attempt to hail boats observed OCS at the start. The failure of any boat to hear the hail, the hail of some but not all OCS boats, the untimely hail of some or all OCS boats, or failure to hail any or all boats shall not be grounds for redress. This changes rule 62.
- 2.4 Except in an emergency, or when retiring from a race, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

3 SIGNALS MADE ASHORE

- 3.1 Signals made ashore will be displayed from the main flagpole located adjacent to the clubhouse.
- 3.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 45 minutes' in race signal AP.

5 CLASS FLAG

The class flag will be the RS21 insignia.

6 COURSES

The course to be sailed will be designated by numeral placards displayed on the race committee signal boat. Course #2 is two legs, rounding the windward mark once. Course #4 is four legs, rounding the windward mark twice and the leeward mark once.

7 MARKS

- 7.1 All marks are inflatable buoys.
- 7.2 The starting line mark is yellow.
- 7.3 The windward mark is red and shall be left to port. The leeward mark is the starting line mark, and shall be left to port.

8 THE START

- 8.1 The starting line is between a staff or halyard displaying an orange flag on the race committee signal boat at the starboard end and the course side of a port-end yellow inflatable buoy.
- 8.2 The start will use RRS Appendix U: Audible-Signal Racing System.

9 CHANGE OF THE NEXT LEG OF THE COURSE

To change the next leg of the course, the race committee will move the original mark (or move the finishing line). Adjustments up to 10 degrees angle and/or 20% distance may be made without signal. (This changes rule 33.)

10 THE FINISH

The finishing line is the same as the starting line.

11 TIME LIMITS

The time limit for each class for the first boat to sail the course and finish is 40 minutes. Boats failing to finish within 8 minutes after the first boat sails the course and finishes will be scored DNF. This changes rules 35 and A4 and A5.

12 HEARING REQUESTS

- 12.1 The protest time limit is 30 minutes after the race committee signal boat docks, as determined by the PRO. This time will be posted online and on the official notice board.
- 12.2 Hearing requests shall be submitted to the SFYC Race Office.

13 HANDLING OF BOATS

[DP] Boats shall have their spinnaker poles in upwind sailing position (retracted) except when on the leg between the windward mark and the leeward mark. Poles shall not be extended until the boat's bow passes the extension of an imaginary line passing between those two marks, and shall be retracted before passing that line below the leeward mark, or at the first reasonable opportunity.

NOTICE OF RACE

Organizing Authority: The San Francisco Yacht Club, Belvedere, California

1 RULES

- 1.1 This event is governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- 1.2 All participants in this regatta shall wear a US Coast Guard approved personal flotation device (PFD) at all times while on the water, except for brief periods while adding or removing other clothing.
- 1.3 The following US Sailing Prescriptions do not apply: RRS 63.1 and 63.2.

2 SAILING INSTRUCTIONS

The sailing instructions will be available by 1600 hours on October 24 on the website, www.sfyc.org.

3 COMMUNICATION

- 3.1 The official notice board is located on the west wall of the SFYC Clubhouse.
- 3.2 On the water the race committee will make courtesy broadcasts to boats on VHF radio channel USA 65A.

4 ELIGIBILITY AND ENTRY

- 4.1 The regatta is open to six teams, of three or four sailors each.
- 4.2 Teams shall be helmed by an SFYC Member and have at least one other SFYC Member on board.
- 4.3 Eligible teams may enter by completing the online registration found at www.sfyc.org > On the Water > Regattas.
- 4.4 Teams will be accepted on a first come, first served basis.
- 4.5 Teams will compete on SFYC's fleet of RS21 class sailboats, utilizing masthead or fractional spinnakers, which will be selected by the SFYC Fleet Manager, and will be the same for all boats. Boats will be identically rigged and tuned, and assigned at random. Teams shall comply with RS21 Class rules regarding racing the boat. Differences between boats shall not be grounds for redress.

5 FEES

- 5.1 The entry fee is \$100 per team.
- 5.2 All teams are required to sign the SFYC RS21 Damage Agreement at check in, which outlines up to \$500 charge per damage incident.

6 SCHEDULE

1000-1030 Check in and Boat Orientation
1030 Competitors' Briefing at the north hoist area (mandatory)
1130 First Warning Signal - 8 races scheduled
After Racing Social, Snacks (organized by SFYC New Wave)

7 VENUE

The intended racing area will be west of Point Knox on Angel Island or Richardson Bay.

8 COURSES

The courses will be windward/leeward type 12-18 minutes long, and will be described in the sailing instructions. All marks will be inflatable buoys.

9 SCORING

When fewer than 5 races have been completed, a boat's series score will be the total of her race scores. When 5 or more races have been completed, a boat's series score will be the total of her

race scores excluding her worst score.

10 RISK STATEMENT

Competitors participate in the event entirely at their own risk and subject to the terms and conditions of the SFYC liability waiver.

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

11 PRIZES

SFYC RS21 glasses will be awarded to the top three teams.
