NOTICE OF RACE

Organizing Authority: The San Francisco Yacht Club, Belvedere, California

1. RULES:

1.1 This regatta will be governed by the 'rules' as defined in the Racing Rules of Sailing (RRS).

1.2 RRS 40.1 is deleted and replaced with: "All competitors shall wear life jackets or adequate personal buoyancy while racing." Note that Flag Y will not be displayed.

2. ELIGIBILITY AND ENTRY:

2.1 The regatta is open to all Mercury Class sailboats. This will be a counter in the Travel Trophy Series.

2.2 Eligible boats may be entered by completing the attached Entry Form and returning it with the entry fee to The San Francisco Yacht Club Race Office.

2.3 The entry fee is \$15.00.

The racing area will be in Raccoon Straits. The courses and marks will be described in the sailing instructions.

6. COMMUNICATIONS:

The Race Committee may use VHF radio to communicate information about the races.

7. SCORING:

At least five races are scheduled. Two races must be completed to constitute a series. All races will count toward the final score.

8. SOCIAL:

The hospitality of the Club is available to all participants and families. Breakfast service begins at 0830, dinner at 1730. Small plate special meals will be available after racing.
