## The Great San Francisco Schooner Race Saturday, August 28, 2010

### NOTICE OF RACE

Organizing Authority: The San Francisco Yacht Club, Belvedere, California

#### **1. RULES:**

- 1.1. This regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS.)
- 1.2 Attention is directed to the fact that the racing rules do not govern the navigation of non-participating vessels, which may be met during the course of the race. Contestants should exercise due caution that there be no violation of the applicable international or inland rules of the road.
- 1.3 RRS 40 is deleted and replaced with: "All competitors shall wear life jackets or adequate personal buoyancy while racing." Note that flag Y will not be displayed.
- 1.4 RRS 44.1 will be changed so that a One-Turn Penalty is required for breaking a rule of Part 2.

**2. ELIGIBILITY AND ENTRY:** The race is open to all schooners setting sail on a main and foremast. Eligible boats may enter by completing the attached entry form and delivering it the SFYC Race Office by mail, fax, or in person by Monday, August 23, 2010. The entry fee is \$150.00, of which \$50.00 will be donated to Spaulding Wooden Boat Center.

**3. DIVISIONS & HANDICAPS:** Divisions and handicaps will be developed by the SFYC Race Committee as follows:

- A. All boats will be assigned to the Marconi or Gaff division by the Race Committee.
- B. All boats will receive ratings assigned by the Race Committee at their sole discretion and not subject to protest.

**4. SCHEDULE:** Boats will start in staggered starting times, based on individual handicaps, beginning at 1200 hours, on Saturday, August 28, 2010. Therefore, winners and finishing places will be determined by the order of finish. Starting times for boats entered will be posted at SFYC and on the Club web page, [www.sfyc.org](http://www.sfyc.org), by noon on Thursday, August 26, 2010.

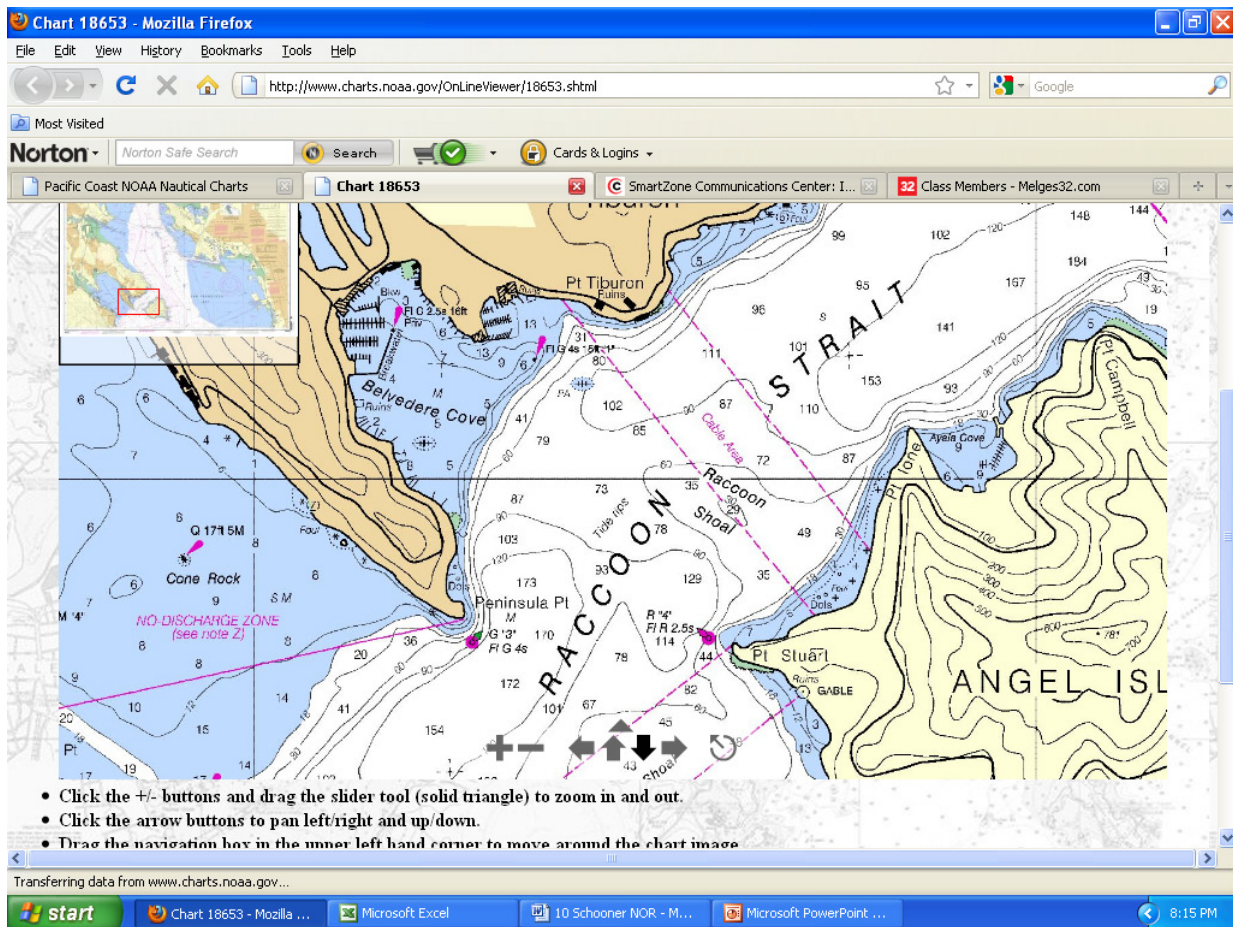
**5. COURSE:** Racing will start in the vicinity north of Knox Buoy (R"2" Fl 4s) and finish in Raccoon Strait. The course(s) will be described in the Sailing Instructions. Sailing Instructions will be available on the Club webpage, [www.sfyc.org](http://www.sfyc.org), by noon on August 26, 2010.

**6. COMMUNICATIONS:** The Race Committee may use VHF 65 to communicate race information.

**7. PRIZES:** The overall division winners, one from Marconi and one from Gaff, will be jointly awarded the Perpetual Trophy, a half model of the schooner *Chispa*. Keeper Trophies will be awarded to first, second and third place finishers in each of the two divisions.

The awards ceremony will take place on the SFYC deck following the conclusion of the race.

**8. SHIPS PARADE:** All racing boats are requested to muster off Point Tiburon (37°52'28"/122°26'93") at 10:30 am on Saturday, Aug 28, for a ships parade through Raccoon Strait at 11:00 am. Please monitor VHF 65 for additional instructions. Additional information will be forthcoming.



## 9. Parking

Parking in the SFYC lot will be restricted during the regatta. We will issue two parking passes per boat. Passes, and offsite parking maps, may be picked up at the SFYC Front Desk on Friday, Aug 27 or at the lot on Saturday, Aug 28.

**10. SCHEDULE OF EVENTS:** All racers are invited to a no-host Sailor's BBQ on the deck on Saturday after the awards presentation. The cost of the BBQ will be \$20.00 and tickets can be purchased in advance with submission of the attached entry form. Additional tickets may be purchased on the deck on race day.
