The Great San Francisco Schooner Race And Classic Invitational

SAILING INSTRUCTIONS

Organizing Authority: The San Francisco Yacht Club, Belvedere, California

1. RULES

1.1 The regatta will be governed by the 'rules' as defined in The Racing Rules of Sailing (RRS).

1.2 Attention is directed to the fact that racing rules do not govern the navigation of non-participating vessels, which may be met during the course of the race. Contestants should exercise due caution that there be no violation of the applicable international or inland rules of the road.

1.3 **BOATS MUST NOT INTERFERE WITH COMMERCIAL OR NAVAL VESSELS OR TUGS AND THEIR TOWS. BOATS DOING SO AND THEREBY ENDANGERING THEIR OWN SAFETY OR THAT OF THE COMMERCIAL VESSEL WILL BE SUBJECT TO PROTEST BY THE RACE COMMITTEE OR CONTESTANTS.**

2. PERSONAL BUOYANCY

Rule 40 is deleted and replaced with "All competitors shall wear life jackets or adequate personal buoyancy while on deck." Note that Flag Y will not be displayed.

3. NOTICES TO COMPETITORS

Notices to competitors will be posted on the official notice board on The San Francisco Yacht Club deck.

4. CHANGES IN SAILING INSTRUCTIONS

Any changes in the sailing instructions will be posted by noon on June 28, 2013.

5. SCHEDULE

Saturday, June 29, 2013 - Warning signal at 1150, first start at 1200 hours. Refer to the schedule of starting times shown on Attachment 1.

6. THE COURSES AND MARKS

6.1 Starting Line - Between a staff displaying an orange flag on the yellow SFYC committee boat “Victory”, anchored between Knox and Point Stuart, and the course side of a red inflatable buoy. Cross the line from east to west.

6.2 Course –All vessels shall sail the same course.

Start- W(P) -A(P) -12(S) -18(P)- KX(S)- PS(S)- finish

Mark Descriptions- W, A, 12 and 18 are rounding marks. KX and PS are passing marks.

W	Weather Mark	Red inflatable ~ 0.4 nm SW of Little Harding
A	Outer Buoy “A”	Yellow Column, St Francis Yacht Club
12	Little Harding	G"1" Fl G 4 sec (1 nm SW Pt Knox)
18	Blossom Rock	RG"BR" Fl G 6 sec bell (1 nm SE Alcatraz)
KX	Knox	Red inflatable ~0.2 nm SSW of Pt Knox (Angel Island)
PS	Point Stuart	R"4" Fl R 2.5 sec (western point of Angel Island)

6.3 Finish Line - Between a staff displaying an orange flag on the SFYC committee boat “Victory”, anchored in Raccoon Straits ~0.2 nm NE of Point Stuart, and the course side of a red inflatable buoy. Cross the line from west to east.

7. THE START

7.1 This changes rule 26. The race shall be started as follows: A ten (10) minute warning signal followed by a five (5) minute preparatory signal will begin the sequence. The first group’s preparatory signal will be removed one (1) minute before the first group’s starting signal. Each succeeding group’s preparatory period will be begin with the start for the preceding group, both of which shall be signaled by the hoisting of a red flag. The red flag will be lowered one (1) minute before the next succeeding group’s starting signal. Times shall be taken from the visual signal; the failure of the sound signal shall be disregarded.

Next Group Start	Red Flag	1 sound	Next group start, etc.

- 7.2 Boats shall start in accordance with individual handicaps beginning at 1200 hours. The committee boat will provide your starting time on request; however, it is each boat's responsibility to start at the proper time.
- 7.3 Boats whose preparatory signal has not been made shall keep clear of the starting area and of all boats whose preparatory signal has been made. Yachts shall not cross the starting line except when preparing to start or starting.
- 7.4 Yachts starting prematurely by less than one (1) minute will be penalized two (2) minutes in calculating their final elapsed time and time to finish. Due to maneuverability concerns, yachts are discouraged from trying to return to the proper side of the starting line again within one (1) minute of their start. This changes rule 29.1.
- 7.5 Yachts starting prematurely by more than one (1) minute will be disqualified unless they return and pass through the starting line again after their designated starting time. The race committee will attempt to notify a yacht starting prematurely by more than one (1) minute via radio communication on Channel 65. This changes rule 29.1.

8. RACING

- 8.1 A yacht that has broken rule 31 may, after getting well clear of other boats, exonerate herself by taking a penalty turn before reaching the next mark of the course.
The penalty turn, for this and for any violations of Part 2 rules, shall consist of a 360 degree turn in the same direction that includes one tack and one gybe. This changes rule 44.1.
- 8.2 Restricted Areas – Yachts shall not pass between these buoys and the closest point ashore.
- a. the Bell buoy off the west end of Alcatraz
 - b. the Pt Blunt buoy off Angel Island

9. TIME LIMIT

- 9.1 Time limit shall be 1700 hours Saturday June 29, 2013. Any boat not finishing by 1700 hours will be scored DNF. This changes rule 35.
- 9.2 Boats not completing the course must report to the Race Committee as soon as possible. The Race Committee Signal Boat will monitor VHF Channel 65.

10. PROTESTS

- 10.1 This changes rule 61.1 All yachts shall inform the protested yacht by hailing immediately and then by the display of a red flag as soon as possible after the incident.
- 10.2 This changes rule 61.3. A protesting yacht is required to notify the Race Committee of her intention to protest at the time she finishes. The Race Committee can be contacted on channel 65.
- 10.3 Protests shall be written on forms available at The San Francisco Yacht Club and lodged there no later than 1730 hours on Saturday June 29, 2013.

10.4 Protests will be heard, in the approximate order of submission, at The San Francisco Yacht Club at 1730 on Saturday June 29, 2013.

11. FINISH PLACES

11.1 Starting times are calculated based on handicaps and starting times are staggered so that winners and finishing places can be determined by the order of finish.

11.2 Yachts racing in all classes will be scored against competitors in their respective classes.

11.3 Schooner classes are defined by mainsail type: Marconi and Gaff.

12. RADIO COMMUNICATION

The Race Committee may broadcast information about the day's racing and OCS on Channel 65. Neither failure of the Race Committee to communicate the sail numbers of recalled boats in a timely manner nor failure of a recalled boat to receive or hear transmitted information will be grounds for redress. This changes rule 62.

13. PRIZES

Prizes will be awarded for the First and Second place for Marconi and Gaff classes. The Trophy presentation will be on The San Francisco Yacht Club deck following race completion.

14. GUEST BERTHING

Guest Docks will be available for boats after the race by reservation.
